



**CLYDESDALE HORSE SOCIETY OF  
NEW ZEALAND (INC)  
LEASE AGREEMENT FOR CLYDESDALE**

Owner does hereby agree to lease to lessee and lessee does hereby lease from the owner  
beginning on the \_\_\_ day of \_\_\_\_\_ 20\_\_, until further notice the following mare:

**RENTAL:** The lessee agrees to pay the owner a total sum of \$ \_\_\_\_\_ for the use of the  
above Clydesdale for the lease period. Lessee warrants that he/she has inspected the  
Clydesdale and agrees to accept said Clydesdale in the present condition and return the  
Clydesdale in approximately the same condition as accepted by the lessee at the  
beginning of the lease period, allowing for age. Lessees shall pay and provide for the  
transportation of the mare from the owner to the lessee and for the return of the said  
Clydesdale to the owner in \_\_\_\_\_ upon expiration of the lease. Lessee shall not  
obligate the owner for any expense of any kind whatsoever in the connection with the  
leased Clydesdale unless authorized in writing by the owner or for a known existing  
condition.

**CARE OF THE CLYDESDALE:** The lessee, at his/hers expense, shall provide feed,  
service, equipment and other necessary service for the proper care, maintenance, handling  
and protection of the leased Clydesdale, also veterinary services if needed, all according  
to the rules of good animal husbandry and reasonable standards and methods of the horse  
breeding industry. Owner shall have the right in person to inspect the said Clydesdale  
within 48 hours notice to ensure the Clydesdale is being properly cared for and is in good  
health. The owner shall assign the registration certificate to the lessee for the purposes  
of permitting the lessee to register the offspring of this Clydesdale resulting from  
breeding from her/him. Upon termination of this lease the Lessee shall assign the  
registration certificate to the owner. The title of ownership of the leased Clydesdale shall  
be and remain in the name of the owner. Lessee shall not sell, mortgage or encumber this  
leased Clydesdale in any manner whatsoever. Lessee shall hold owner harmless for any  
injury to persons or damage to any property caused by this leased Clydesdale. Lessee  
shall not permit the leased Clydesdale to be seized or impounded by anyone because of  
damage to property of others. Lessee shall pay when due any taxes which may be levied  
by any city, township, county, state, or other taxing body wherein said leased Clydesdale  
may be located during the term of said lease. Lessee shall not assign this lease nor  
sublease this Clydesdale covered hereby. If the leased Clydesdale should at any time

become missing, lost, strayed, seriously injured, sick or dead the lessee shall immediately notify owner by telephone and subsequently by mail. In the event the Clydesdale mare does not foal from the first breeding season the lessee may breed her at the next breeding season and return the mare after the offspring is weaned. If the mare does not produce offspring within twelve months after the second season breeding, this lease shall terminate and the lessee shall return the mare to the owner as hereinabove provided.

**MODIFICATION OF LEASE:** No modification of this lease shall be binding unless in writing and executed by parties hereto.

**BINDING OF HEIRS:** It is further agreed that this lease and all covenants and agreements herein contained shall occur to and be binding upon the parties hereto, their heirs, successors administrators, executors and assigns.

**ADDITION:** The lessee shall provide, free of charge, a service to a stallion owned and in possession of the lessee, to a mare owned and bred by the owner, for each live foal breed from the leased mare above. The service is not transferable or exchangeable for monies.

**IN WITNESS WHEREOF:** The Owner and the Lessee have executed this lease on the day and year above written.
